# HHS issues powerful statement about discrimination against people living with hepatitis B pursuing careers in health care

We applaud the U.S. Department of Health and Human Services (HHS) for issuing a letter to health professions schools in the U.S. that calls for renewed attention to admissions and clinical placement policies and their obligation to comply with federal civil rights laws that protect the rights of people living with hepatitis B. The letter from Admiral Brett P. Giroir, assistant secretary for health, and Roger Severino, director of the HHS Office for Civil Rights, highlights current recommendations from the U.S. Centers for Disease Control and Prevention (CDC) for hepatitis B-infected health care providers and students. Kat's father has hepatitis B, but nobody in the family was willing to talk about it. For years, they weren't allowed to share the same chopsticks or eat dinner with him. As Kat grew older, she learned how hepatitis B is actually spread and shared this information with the family. She also

### Hepatitis B Foundation journal pick of the month

The case for simplifying and using absolute targets for viral hepatitis elimination goals

Following on the 69th World Health Assembly's endorsement of the goal to eliminate hepatitis infection as a public health threat by 2030 and the World Health Organization's (WHO) global targets for the care and management of hepatitis B virus (HBV) and hepatitis C virus (HCV) infections, the authors propose simplified and specific targets. The objective of these recommendations, the authors write, is to provide more understandable targets that recognize countries' previous and existing elimination programs, assist with the assessment of progress towards actual elimination and encourage other countries to pursue their own elimination initiatives.
