# 3:10 pm: Presentation: Stigma and Discrimination

Presenter: Mohamed Ali, Public Health Manager for Seattle and King County, WA Presentation slides are attached.

- Hepatitis B screening and testing has been conducted for many years in King County, Washington State.
  - Some of the Lessons learned through these kinds of events are:
  - 1) Hep B testing
  - Patient education is important to increase participation in testing. Incentives are helpful to get more interest.
  - There are structural and systematic barriers to conducting testing events. Drawing blood requires skilled professionals. It is helpful if volunteer doctors and nurses can be recruited.
  - CDC has mentioned that this kind of approach has been effective in testing and screening for Hep B.
  - These kinds of programs are rare now which makes It difficult for patients with hep B to advocate to get themselves tested.
  - 2) There is a lot of stigma surrounding hepatitis B. This is due to lack of awareness and education. There is also a lot of misinformation and ignorance about the disease.
  - 3) In countries like Somalia and Ethiopia, sometimes viral hepatitis is confused with other infectious diseases like malaria and jaundice as the signs and symptoms are similar. There is also confusion regarding different types of hepatitis. People tend to turn to spiritual healing to cure the disease.
  - Between 2020-2022 a lot of Somali women passed away due to liver issues in Minneapolis. They did not get adequate medical help due to stigma relating to hepatitis that exists in their communities.

Presenter: Cait O' Donnell (African Family Health Organization)

- AFAHO was founded in 2005. Their clients are mostly female. They conduct health, social, and educational programs. Their health programs are focused on increasing testing, immunization, and health access for the population they serve regardless of their immigration status. They focus on helping communities to navigate the health care system and advocate for the care they deserve.
- There is a lot of stigma surrounding hepatitis B in the communities they serve. Hepatitis B is often confused with malaria and jaundice as all of these infections share similar signs and symptoms.
- The burden for hepatitis B is high in these communities. People fear testing as a positive test will require follow up action on their part and navigating that is not easy.
- AFAHO works with these communities to reduce the anxiety around testing and help these communities navigate testing, screening and follow up visits.

## 3:46 PM Adama's story: Discrimination and Stigma surrounding hepatitis B

• 10 years after his mom passed away, Adama realized he has the same infection - hepatitis B. Adama has been managing his hepatitis B and receiving treatment but is concerned about the low awareness of hepatitis B in his community, as well as reduced access to treatment following the COVID-19 pandemic.
